ROSEBUD SIOUX TRIBE GAME, FISH AND PARKS GENERAL REGULATIONS



Non-resident are required to have a registered RST Tribal member guide to hunt the Rosebud Indian Reservation, per Resolution 00-150.

A general hunting license is required of all hunters. A hunting permit is required for the specified season and species. Hunters between the ages of 12 and 15 years must possess a hunter safety card.

In order to hunt, a person must be at least 12 years old.

A big game permit is required to hunt big game. An upland bird permit is required to hunt upland birds. A waterfowl permit is required to hunt waterfowl. A predator/varmint permit is required to hunt predators and/or varmints for non-members.

It is unlawful for a firearm to protrude from a motor vehicle or conveyance.

It is unlawful to have a hunting party greater than 20 persons.

Hunting methods shall be restricted to shoulder guns, large caliber handguns, and bow and arrows.

Use of artificial lights is prohibited except for the taking of treed raccoons using dogs.

It shall be unlawful to hunt or discharge a firearm from a motor vehicle or any motorized conveyance.

Use of aircraft for hunting big game is prohibited.

Tribal Members do not need to apply except for limited antelope permits and limited elk permits. Tribal deer licenses are available one month before the season opens.

It shall be unlawful to waste game.

It is unlawful to possess any illegally taken game or to hunt outside of season dates.

Any person having any game bird, animal, or fish shall allow inspection by official RST Game and Fish personnel. Any motor vehicle or conveyance may be stopped for inspection and count.

Use of radio communication while hunting shall be unlawful.

It shall be unlawful to accompany any licensed permittee in the field with any type of weapon without holding a permit.

It is unlawful to misrepresent, to transfer, or to alter a license.

It shall be unlawful to destroy property, tribal signs and fences or to leave gates open.

Any person convicted of a violation shall be subjected to a fine not to exceed \$500.00 and/or receive a sentence of no more than 6 months in jail. In addition, civil penalties may apply. Tribal members shall be subject to tribal courts, non-members shall be subject to federal court.

BIG GAME REGULATIONS

All big game taken must have a tag securely attached to either a leg or to an antler before loading in to or onto any conveyance. The tag must be signed. The tag must be dated the day of harvest.

Baiting is unlawful.

Evidence of sex must be left on the carcass.

Silenced weapons are illegal.

No person shall scare, chase, harass, disperse or otherwise disturb wildlife other than by legal hunting methods.

No big game permittee while hunting in the field shall be accompanied by any non-permittee carrying any type of weapon. Once a permittee has filled their permit they must retire their weapon.

It shall be unlawful to hunt big game with a cartridge less than two inches in length which discharges a projectile of a diameter less than 22/100 of an inch. Ammunition must have a soft point or expanding bullet.

Big game may be hunted with large caliber handguns of .41 caliber or larger with at least a 4 inch barrel length.

It shall be unlawful to hunt with a muzzle-loading weapon that discharges a projectile with a diameter of less than 42/100 of an inch.

No self-loading (semi-automatic) firearm that holds more than six cartridges may be used.

Bows shall pull no less than 40 pounds at a 28 inch draw. Arrowheads must have a cutting edge of 7/8 of an inch wide and be no less than 1 ½ inches long. The arrow shaft must not be less than 24 inches long. Arrowheads must be of reasonable sharpness.

It shall be unlawful to use buckshot to hunt big game or to use a slug weighing less than ½ ounce.

It shall be unlawful to use dogs to hunt big game.

It shall be unlawful to hunt big game for another person.

It shall be unlawful to use artificial light to hunt big game.

Archers shall not possess any firearm while hunting during any archer season.

The possession, sale or transportation of illegally taken game birds, animals or fish by any person shall be a misdemeanor.

No person using a bow and arrow shall use explosive points, poisonous points, barbed points or a crossbow.

Spring Turkey Season limited to, male birds, Shotgun or Archery only (Turkey Shooting hours are sunrise to sunset.)

Special Hunts

Buffalo and elk hunts are available through the Game, Fish and Parks Department. Buffalo and elk hunts run on a time limit and fair chase rules apply.

The minimum caliber allowed for buffalo and elk hunts is 270.

Buffalo hunts are available year round and are enclosed in a pasture.

Elk hunts are available by bid for a Trophy Bull or drawing for a cow. The Elk are free roaming.

SMALL GAME REGULATIONS

An upland bird permit is required to hunt upland birds.

A federal duck stamp and a tribal waterfowl stamp is required to hunt waterfowl for non-members, an upland bird stamp for tribal members.

While hunting waterfowl a shotgun may not hold more than three shotshells. Shotshells must be steel shot.

Hunting of rabbits and squirrels is allowed year round with purchase of a general hunting license.

TRAPPING REGULATIONS

Trapping of furbearers on the Rosebud Indian Reservation is open to tribal members only.

Traps must be checked every 48 hours.

It shall be unlawful to disturb another's trap.

Traps may not be set within 200 yards of any dwelling or public area.

It is unlawful to trap game animals or protected species.

It is unlawful to use a trap larger than #4.

Trapping of bobcats is allowed from December 11 to February 28 and upon harvest each bobcat must be checked in at the RST Game, Fish and Parks Office.

No furbearer may be held in possession, except one may be kept as a pet and may not be altered in any way.

Raccoons may be hunted with dogs. A spotlight may be used once the raccoon has been treed. Only a shotgun may be used for treed raccoons.
